Which products and materials do we not discharge?

In general, we discharge all products in accordance with the legal requirements with the following exceptions:

- In countries not listed above, we do not take care of the discharge. Customers (such as processors, dealers and end customers) who import our products into such countries are themselves responsible for the discharge or for environmentally friendly and legally compliant disposal.
- We do not discharge products that are delivered to the above-mentioned countries and further processed there (e.g. installation in door leaves, door fittings, mailboxes, etc.). In these cases, the respective importer or processor is responsible for the discharge.

Why is discharging important to us?

By working with certified systems, we ensure that valuable raw materials are recycled and environmental impact is minimized. This not only complies with legal requirements, but also actively contributes to a more sustainable future.

We consider the proper disposal of our products to be an important part of their quality. Even at the end of a product's life cycle, ekey still stands for quality!
